Mere inclusion of the Register Number of candidates in the list does not confer any right on the part of candidate for participation in Oral test.

NOTES:

- 1 Mere inclusion of the register numbers of candidates in the above list will not imply that his/her candidature has been fully considered for next stage of selection.
- 2 The admission of candidates to oral test/CV and OT is provisional subject to verification and acceptance of the claims in their online applications towards Age, Educational Qualification, Community, Cooperative Training, PSTM status etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to oral test will becancelled and they will not be admitted to next stage of selection.
- 3 Candidates who have been admitted provisionally to the oral test/CV and OT are hereby advised to attend the oral test with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.

The candidates are also advised to attend the interview with all noted below documents in original and one set of photocopies (Xerox) of all documents with Self attested without fail. Failure to produce even any one of the essential documents at the time interview will result their non-admission to the interview.

candidates absent themselves for interview, they will not be considered for next

stage of selection.

provisional subject to the decision of the District Recruitment Bureau,

Tiruvannamalai and subject to the final orders to be passed by the Hon'ble High

Court of Judicature at Madras in the WPs and othercases pending on the files
